Mayor Whitlow announced that the public hearing was now open at 6:32 p.m.

Russell Cain was in attendance and commented he was there on behalf of the owners of 420 N. Colorado Street. Cain requested Council give him at least 60 days to be able to address this situation. Safety Public Director Calagna advised Council that this was only the beginning of the process for the condemnation of substandard buildings. These six substandard buildings had been discussed at a city council workshop held on August 09, 2012 where a Power Point presentation showed various slides depicting the condition of each. Calagna also stated that some of these buildings have been the source of safety complaints from citizens and the last known owners had been notified, by certified mail, of date and place for this public hearing. City Manager Turner commented it would probably be around the first of the year before any condemnation procedure was actually passed by Council; therefore, allowing Russell Cain the 60 days requested.

## CONSIDER RESOLUTION NO. R-091012-1 AUTHORIZING SUBMISSION OF APPLICATION TO THE COASTAL MANGEMENT PROGRAM (CMP) FOR CYCLE 18 FOR T-HEAD ON THE FISHING PIER AT LIGHTHOUSE BEACH

WHEREAS the Texas Coastal Management Program is currently accepting applications for matching grant funds under the Cycle 18 Program Year to assist local entities in implementing improvement projects in the Coastal Management Zone; and

WHEREAS the City desires to ensure that the public has a safe and adequate area for public fishing in Lavaca Bay wherein the coastal resources are protected while providing its citizens and visitors with adequate access to the coastal waters; and

WHEREAS, the City utilized Coastal Management Program grants funds awarded in Cycles 8 to 15 to begin reconstruction of the Lighthouse Beach Fishing Pier, and

WHEREAS, the City desires to submit an application to the Texas Coastal Management Program grant program for Cycle 18 funds because it lacks sufficient financial resources to construct a T-head termination point at the Lighthouse Beach Fishing Pier without assistance; and

WHEREAS, the City Council of the City of Port Lavaca, Calhoun County, realizes the CMP grant program requires the City to provide at least 40% of the total project cost as a local contribution;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PORT LAVACA, TEXAS:

- Section 1. That the City is authorized to submit an application to the Texas Coastal Management Program for Cycle 18 funding assistance to continue renovations to the public fishing pier in Lighthouse Beach Park; and

WHEREAS, the Federal Disaster Mitigation Act of 2000 and Federal Emergency Management Agency (FEMA) require communities to adopt a hazard mitigation action plan to be eligible for the full range of pre-disaster and post-disaster federal funding for mitigation purposes; and

WHEREAS, FEMA requires that communities update hazard mitigation action plans every five years in order to be eligible for the full range of pre-disaster and post-disaster federal funding for mitigation purposes; and

WHEREAS, the City of Port Lavaca has assessed the community's potential risks and hazards and is committed to planning for a sustainable community and reducing the long-term consequences of natural and man-caused hazards; and

WHEREAS, the GBRA's Hazard Mitigation Plan Update outlines a mitigation vision, goals and objectives; assesses risk from a range of hazards; and identifies risk reduction strategies and actions for hazards that threaten the community.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PORT LAVACA, THAT:

- 1. The GBRA's Hazard Mitigation Plan Update is approved in its entirety;
- 2. The City of Port Lavaca will pursue available funding opportunities for implementation of the proposals designated therein, and will, upon receipt of such funding or other necessary resources, seek to implement the actions contained in the mitigation strategies;
- 3.
