CONSIDER GENERATOR RENTALS FOR UTILITIES FACILITIES

Public Works Director Pena advised Council that the City currently has no backup power for the wastewater treatment plant, the two primary main lift stations or the Public Works Service Center, which is manned during emergencies. He said staff is in the process of procuring grant funds to purchase generators, if possible; however, this will not occur in the immediate future and hurricane season is already upon us. He said numerous vendors have been contacted in an effort to get pricing for reservations of generators. The quotes submitted are as follow:

United Rentals	\$ 63,079.60	
Holt Power Systems	\$ 56,757.70	(Recommend this Quote)
Romco Power Systems	\$ 28,830.00	(No equipment setup)

He stated these rates are for the period of five (5) months and includes one generator for the WWTP, one for the Public Works Service Center and one for each of the primary lift stations. He also said that funds for this emergency procurement would have to come out of the Utility Fund reserves because no funding was provided in this year's budget.
