CIP FY 2020-2021 changes: \$450,000 Smith Harbor dredging - FY 2020-2021; \$50,000 in Economic Development was deleted and moved to Port Commission - FY 2020-2021. \$220,000 repairs to Evelyn's was moved to - FY 2024-2025; \$250,000 Sandblast and recoat bulkhead at lower dock was moved to - FY 2025-2026; Bulkhead improvement to Smith Harbor was added at \$375,000 FY 2021-2022 and \$375,000 FY 2022-2023.
