# 4. RECEIVE REPORTS FROM URBAN ENGINEERING AND STAFF ON LOW DOCK REPAIRS AND STATUS.

Comments from Matt Glaze, Urban Engineering J&S has completed everything apart from the concrete and the mooring cleats. Concrete was scheduled but was delayed due to the weather. J&S is approaching the end of their contract.

- RECEIVE REPORTS FROM URBAN ENGINERRING AND STAFF ON SCULLY'S BULKHEAD AND FINGER PIER REPAIRS. Comments from Matt Glaze, Urban Engineering project is complete except for the aluminum handrails and grass. Finger piers are all complete. No action necessary and none taken.
- 6. RECEIVE REPORTS FROM STAFF REGARDING STATUS OF NAUTICAL LANDINGS BUILDING AND FRONT PARKING LOT. Comments from Jim Rudellat, Harbor Master received the new doors and windows for NL Building. Two broken waterline pipes were repaired to the NL Building due to the freeze. Water meter is being monitored and verifying with Public Works to see if meter can be relocated. No action necessary and none taken.
- 7. RECEIVE REPORTS FROM STAFF REGARDING STATUS OF NAUTICAL LANDINGS MARINA.

Comments from Jim Rudellat, Harbor Master, NL Marina had 17 broken ball valves repaired on Dock-A due to the freeze.

9. RECEIVE REPORTS FROM URBAN ENGINEERING ON DREDGING OF SMITH HARBOR, ASSOCIATED PROPERTIES.

Comments from Matt Glaze, Urban Engineering presented the plans at the last Port Commission meeting on February 2, 2021. Nothing has significantly changed, advertising on March 10<sup>th</sup> and March 17<sup>th</sup>. Prebid's on March 18<sup>th</sup> and open bids on March 25<sup>th</sup>.

Comments from Alex Davila to Matt Glaze, concrete that was carved out that collapsed into the harbor needs to be broken up or pulled out.

10. RECEIVE UPDATE FROM STAFF ON COMMUNICATIONS WITH TCEQ AND ARMY CORP OF ENGINEERS REGUARDING HARBOR OF RUFUGE.

Comments from Jody Weaver, City Engineer, submitted to TCEQ Municipal Solid Waste Division a restoration plan. CRG Environmental will be checking the site weather permitting. No action necessary and none taken.

## 11. RECEIVE REPORTS FROM STAFF ON HARBOR OF REFUGE, BULKHEAD REPARS AND LAND IMPROVEMENTS.

Comments from Jim Rudellat, Harbor Master, no updates to report.

Comments from Commissioner Raymond Butler, Lavaca Bay Foundation will be meeting on March 10, 2021. Core of Engineers will be discussing the placement area plan of the new channel. Raymond Butter asked Jody Weaver to please attend. Comments from Alex Davila, Chairman, reminded Commissioner Raymond Butler, to keep in touch with Jody Weaver, regarding the corporate clean up. Port Commission needs to the have the first right of refusal on any of the material that gets pulled out. Jody Weaver, City Manager to get with TX-Dot for any extra material be given to Port Commission. No action necessary and none taken.

## 12. DISCUSS UPDATES ON BRUSH OPERATOINS AND CLEANUP AT THE HARBOR OF REFUGE.

Comments from Jody Weaver, City Manager, located a piece of equipment known as an Air Burner to be positioned at the Harbor of Refuge to burn brush. Air burner will be relocated to another area for long term brush disposal. Discussed with City Council at the last workshop on permitting for the Air Buner, the buffer zone for this equipment must be within 300 feet of the property line and 300 feet from any building. Location for the first phase would be the Harbor of Refuge however we must verify that there is not any buried trash where the Air Burner will be placed at. The Air Burner will need to be relocated for long term. Will be looking at several sites.

*d. Smith Harbor*: Comments from Alex Davila, Chairman invited Joey Perez, Code Enforcement Officer to inform Port Commission on the white pickup located at the City Harbor. Comments from Joey Perez first step will be working with the Police Dept to identify the owner of the vehicle.

*d. Smith Harbor*: Comments from Alex Davila, Chairman, asked Jim Rudellat, Harbor Master to get with Shirley and Sons to remove their crane from City Harbor so Gonzales Contracting can clean, level, and dress the area as well as removing the white pickup so Port Commission can move forward in leasing the property. Also, requested that the slope be cured at the west end of the City Harbor.

*e. Harbor of Refuge*: Comments from Jody Weaver, City Manager, the railroad on Helena Chemical property was found to be in dangerous condition. We authorized to move forward for the emergency repairs. The quote for the repairs was for \$30,000.00 dollars. Work has been begun and will be completed by the end of the week. Contractor will get with Jim Rudellat, Harbor Master to discuss the entire scope of the project and give an estimate for long term repairs. If repairs are significant, we will need to come up with a scope of work and go out for bids. Two bids were submitted for the emergency repairs.

*e. Harbor of Refuge*: Comments from Jody Weaver, City Manager, regarding permit for the bulkhead still pending.
